INVITATION FOR FRESH ENROLMENT / RENEWAL OF ENROLMENT OF CONTRACTORS FOR THE BLOCK PERIOD 2020-2025.

The VJNL has planned to complete two ambitious projects of State for providing safe drinking water & irrigation facilities viz., Yettinahole Integrated drinking water Project & Upper Bhadra Project under its jurisdiction expeditiously. It is proposed to tender large number of balance works of canal, distributaries, CD works, barrages, reservoirs and head works of Lift Irrigation schemes, Water Supply Schemes and Roads etc.

1. The VJNL has enrolled contractors for block period of 2015-2020 which is going to expire on 30.06.2020. Now, VJNL invites fresh / renewal applications from all eligible contractors/agencies for Fresh enrolment / Renewal of enrolment under different categories for the present Block Period 2020-2025.
2. The major portion of works are proposed to be tendered under the following categories:
 - a) Category – III Works costing more than Rs.2.00 crores and up to Rs.5.00 crores.
 - b) Category – II Works costing more than Rs.5.00 crores and up to Rs.15.00 crores.
 - c) Category – I Works costing more than Rs.15.00 crores.

Only such of the contractors who are qualified and enrolled in the select lists of contractors will be eligible to participate in VJNL tenders. The VJNL, however, reserves the right to separately pre-qualify contractors for works of specialized nature.

3. Only the Class-I contractors registered with PWD of Karnataka are eligible to apply for enrolment.
4. The blank application forms, along with detailed instructions for the Fresh enrolment / Renewal of enrolment in the select lists will be available in this office on payment of a non refundable amount of Rs.1120/-(Rupees one thousand one hundred twenty only). The amount shall be payable through Demand Draft drawn on any scheduled bank in favour of “Visvesvaraya Jala Nigam Limited” payable at Bangalore. The blank application forms can be collected during office hours at registered office VJNL, Bangalore on production of attested copies of the Class-I registration certificate issued by PWD, Government of Karnataka in the name of applicant & GST along with application fee in the form of DD.
5. Application forms will not be sent by post.
6. Prescribed application form duly completed in all respects, accompanied with non-refundable DD towards prescribed enrolment fee for respective category as given below is to be submitted at the office during office hours.
